- Analyze and rank four animals based on basic priority traits and correctly mark a standard placing card
- Develop organized notes that accurately describe the evaluated livestock
- Formulate a basic oral reasons speech that is organized in the standard format
- Present an oral reasons speech without the aid of notes

Grading Procedure: Your final grade in these courses is based on the following:

(Placing Avg x 12) + (Reasons Avg x 6) + (Participation Pts = 600 total (20×30 pts)) divided by 1500. Placing and reasons averages will include both practice and contest results.

Example:

A student averages 48.5 on all placing scores and 37 on all reasons scores while missing a total of five participation events (class or contests).

$$(48.5 \times 12) + (37 \times 6) + 450 = 1254/1500 = 84\%$$
