#### **Course Description:**

Builds on the knowledge acquired in NUR 268C and continues to focus on nursing management, critical thinking, and safety with regard to medication therapy. Includes the topics of: pharmacokinetics, pharmacodynamics, specific drug therapies, interactions of the drug groups which are applicable to the content provided in NUR 201A. Uses drug lists for each major category of drugs to direct learning for drug action, safe dosage, side effects, drug interactions, adverse reactions and nursing implications.

### As a result of this course the student will achieve the following outcomes:

- 1. **Management of Care:** Practice in a manner consistent with the Code of Ethics for Registered Nurses.
- Safety and Infection Control: Follow procedures for handling biohazardous materials.
- 3. **Health Promotion and Maintenance**: Assess the impact of change on family dynamics and medication management.
- 4. **Psychosocial Integrity:** Assess client's and family's ability to cope with end-of-life issues and the medications involved.
- 5. **Basic Care and Comfort**: Assess the client's need for palliative care/symptom management or non-curative treatments.
- 6. **Pharmacological and Parenteral Therapies**: Identify actual and potential incompatibilities of prescribed medications.
- 7. **Reduction of Risk Potential:** Perform appropriate focused assessments prior to medication administration.
- 8. **Physiological Adaptation:** Apply knowledge of pathophysiology when caring for a client with a medical emergency receiving supportive medication therapies.
- 9. Professional Engagement: Participate in reflective practice.

### To achieve the course outcomes, student will achieve the following clinical goals:

This class has no clinical component; however, content within this course is directly applicable within the core nursing courses (NUR101 – NUR203) and clinical goals within those courses will require knowledge obtained within this course. Students will be expected to demonstrate knowledge and understanding of medications. These may be applied to virtual simulations or the clinical setting. The student will best be able to demonstrate this by the following:

- Justify the appropriateness for medication(s) within a specific patient care situation.
- Prepare or withhold medications based on evidence and judgment.
- Calculate accurate dosages, times, measures and volumes of medications as well as accurate weights of patients.
- Select non-drug complementary measures/nursing interventions to promote therapeutic effects of medications.
- Identify nursing interventions/actions appropriate to the situation based on early recognition of adverse drug effects.
- Identify appropriate administration methods for medications using established safety protocols, minimizing adverse interactions, and incorporating patient education.
- Evaluates the effectiveness of medications and compares therapeutic results compared with baseline data.

**Learning Activities (may include any of the following but not limited to):** Return demonstration of skills, lecture, group activities, written work, discussions, case studies, concept maps, online learning activities, ATI activities, and clinical activities.

# Evaluation of learning which results in a grade will be determined by:

1. Quizzes: Multiple choice, short answer and fill in the blank questions may be used, as well as alternate item format questions (questions that pertain to pictures, graphs or documents). Quizzes will be posted online on the NUR268D Moodle website. These will not be proctored quizzes, but it is expected that you complete them independently in order for you to be successful on the midterm and final exams. They should be completed by the deadline on the course schedule. If a quiz is not submitted by the deadline, it will be graded as a zero, unless there is notice given to the instructor prior to the deadline.

2. Drug Cards: Points for drug cards will be determined in two ways. The first drug card evaluation will be an evaluation of a single drug card of the instructor's choosing.
