COURSE DESCRIPTION: This course covers accounting theory and procedures for governmental and not-for-profit entities, including budgetary and expenditure control. It builds understanding of basic concepts like accountability, financial statements, and transactions such as recording budgets and property taxes.

COURSE REQUIREMENTS: Work assignments for this course will include end of chapter questions (T/F, multiple-choice, matching, Journal entries), and end of chapter quizzes of similar composition. Homework and Quizzes will be completed during assigned timeframes on McGraw Hill's "CONNECT" lab in support of the textbook. No credit will be given for late assignments.

"VIRTUAL" vs "ONLINE"

There is a big difference between the meanings of "Virtual" format and "Online" classes.

The modality of this course is the "Virtual" format, which means that your attendance and participation are expected during scheduled class times; just as if we were attending in the brick & mortar. This is not the same as an "Online" course where you come and go as you please.

I plan on recording each class for backup / emergency purposes for students who cannot attend. Class session recordings **are NOT** intended to serve as an alternative to attending classes during scheduled times.

If you cannot attend, you cannot earn participation points, which will weigh in for 8.70% of your total grade calculation.

In the "Online" class format, what you do and when you do it is entirely up to you, and there is no interactive component with an Instructor. While a lot of the work you do will be performed in McGraw Hill CONNECT outside of class meeting times, this is not an "Online" class.

If you cannot attend during scheduled class meeting times, you may still enroll, but you'll need the strength and motivation to get through the course by viewing recordings and doing all of the required work in the publisher's lab completely on your own. I do not recommend taking this path if you can avoid it.
