#### **Course Description**

NUR 201B is the fourth course in the lab series. Focuses on clinical application of both theory and skills in the lab, hospital, mental health, rehab, and community care settings. Builds on the identification of patient problems/nursing diagnosis, planning, and implementation of basic nursing care. Students demonstrate nursing skills, clinical judgment, priority management and strategic intervention in the laboratory clinical application portion of the course.

## **Student Learning Outcomes**

- Management of Care:Manage and direct care for two acute care clients addressing priority problems; practice within the legal and ethical parameters of the nursing profession.
- Safety and Infection Control: Implement appropriate nursing actions safely and effectively to meet client and family needs

- Health Promotion and Maintenance: Integrate and follow established protocols to reinforce basic health promotion and self-care education to clients and families.
- Psychosocial Integrity: Implement culturally competent care and integrate psychosocial nursing diagnoses into the nursing care plan.
- Basic Care and Comfort:Demonstrate basic care and comfort for all clients.
- Pharmacological and Parenteral Therapies: Identify appropriate nursing responsibilities in the delivery of medications, blood products and/or infusions. Implement responsibilities appropriately with faculty supervision.
- Reduction of Risk Potential: Implement logic and problem-solving skills when evaluating the nursing process to improve client outcomes
- Physiological Adaptation: Continually assess clients in order to identify findings that are abnormal and changes in the client condition across the lifespan
- Professional Engagement: Demonstrate professional communication with peers and colleagues; use reflective practice to identify learning needs and improve nursing care.

## Grading

Evaluation of learning which results in a grade for the course will be determined by clinical performance which is a combination of performance and participation in clinical activities, Skill/Simulation and IPE. Clinical performance is on a PASS / NO PASS basis. Attendance and participation in all clinical experience is critical to student success. Components of determining the grade include all areas of the clinical evaluation tool. Students should be advised that this also includes participation in all skills/simulation curriculum and the completion of all assigned materials and exercises. Of special note are the following areas which apply to all clinical settings:

- A. Practices within the parameters of skill competency and knowledge level in the setting.
- B. Evaluates personal clinical performance and modifies his/her nursing practice accordingly in the setting.
- C. Seeks feedback and assistance appropriately and incorporates feedback to improve performance in the setting.

Clinical performance is evaluated with a mid-term at week 5-6 and at the end of the term. Clinical instructors are permitted to evaluate student performance as frequently as necessary to determine achievement of course outcomes.

Students must pass NUR201A and NUR201B courses concurrently in order to progress to the next sequence of the program.

<u>Skills / Simulation Lab performance</u> is evaluated as part of the clinical experience. Participation in this learning environment is mandatory and may require preparatory activities above those assigned to the other members of the course on the assigned weeks. Absences will be tracked on the <u>LBCC Attendance and Participation Tool</u>, absences may require students to complete make-up clinical shifts. Students are to acquire new skills and have their individual performance validated as correct. Students may be mandated to make-up skills/simulation time prior to continuing on to the off-campus clinical experience. Students may also be mandated to remediation and/or

a traditional "check-off" experience in order to determine progression. The lab areas are considered as clinical areas and students are to wear clinical attire when participating in assigned instructional time in those areas. Students should review the Uniform Policy.

<u>Participation and engagement in Interprofessional Education(IPE):</u> The LBCC Nursing Program is committed to engaging in IPE to improve communication and quality healthcare. We have partnered with Western University Medical School to bring a variety of healthcare students together to accomplish this. IPE is considered required clinical time, absences will be tracked on the <u>LBCC Attendance and Participation Tool</u>, absences may require students to complete additional academic assignments in order to meet outcomes.

- IPE is coordinated by representatives from all partnering educational organizations and hosted through Western University Medical Schools course sites via Blackboard. Access to and enrollment will come to you via an email.
- IPE classes are scheduled on Wednesday afternoons (across the academic year and meet virtually from 4:00-5:30 PM.
- All information about the class and expectations are posted on the course site.
- Students are required to self-enroll in the course site.
